C.F. Sauer Foods Issues Allergy Alert on Undeclared Milk in one lot of Gold Medal Spaghetti Sauce Mix – 1.37 ounce pouch

FOR IMMEDIATE RELEASE – August 4, 2008 – CF Sauer Foods Inc, of Richmond, VA is recalling all packages of Gold Medal Spaghetti Sauce Mix with the code date as follows: 8119R. People who have an allergy or severe sensitivity to milk run the risk of serious or life **threatening** allergic reaction if they consume these products.

GOLD MEDAL SPAGHETTI SAUCE MIX was distributed through retail stores in Mississippi, Kentucky, and Alabama.

The Spaghetti Sauce Mix comes in 1.37 ounce pouch and was sold under the name Gold Medal displaying a UPC code of 0-52500-02104-7.

The recall was initiated after it was discovered that the **Spaghetti Sauce Mix** containing milk was distributed in packaging that did not declare the presence of milk. Subsequent investigation indicates the problem was caused by an oversight in the company's development process.

FAQ CONCERNING GOLD MEDAL SPAGHETTI SAUCE MIX RECALL OF 8/2008

WHAT PRODUCT IS INVOLVED?

Only one production run of one item is involved: Gold Medal brand Spaghetti Sauce mix in the 1.37 ounce pouch with the item code under the UPC bar of 0-52500 02104-7.

WHAT IS WRONG WITH IT – WILL I GET SICK IF I EAT IT?

If you have an intolerance or allergy to milk or, specifically Romano cheese, you should not eat this product and can return it for a full refund. The packaging was printed with an incorrect ingredient statement that did not include the allergen information.



HOW DO I KNOW IF THE PRODUCT I HAVE IS INVOLVED IN THIS RECALL?

Look for the specific lot code: 8119R. It is embossed on the left side seal of each package on the front panel near the picture of the plate of spaghetti.

WHERE DID THIS GET SHIPPED?

This lot was distributed to retail stores in three states: Alabama, Mississippi, and Kentucky.



WHAT SHOULD I DO IF I HAVE ONE OF THESE PACKAGES?
